HIGHWAYS ACT

Pursuant to section 3 of the *Highways Act*, the Minister of Highways and Public Works orders as follows:

1. The Deputy of the Minister to whom the administration of the Act is assigned or a person authorized by that Deputy Minister may from time to time exercise the power of the Minister under subsection 24(2) of the Act and section 8 of the *Highways Regulations* and reduce the maximum allowable vehicle weights for any highway or part thereof to ensure the safety of persons using the highway or to prevent excessive damage to the highway.
2. The reductions imposed under section 1 shall not exceed 50% of the maximum allowable vehicle weights for any highway or any part thereof.
3. The reduced maximum allowable vehicle weights imposed under section 1 are the maximum allowable weights for the purposes of the *Highways Regulations*.
4. Notice of the reductions imposed under section 1 shall be given as required by subsection 8 of the *Highways Regulations* modified to suit the case.
5. This order comes into force on March 1, 2004 and continues until October 31, 2004.
