1. If at any time a person who is not a member of the Legislative Assembly becomes Premier, ex gratia payments in accordance with sections 2 and 3 may be made to the person.
2. The amount payable under this Order to a person, for each day on which the person is Premier but is not eligible for remuneration under the Legislative Assembly Act, is the amount determined by the formula  
$$A/365$$
where A is the total of the amounts described in subsections 41(1) and 42(1) of that Act.
3. Payments under this Order may be made by the Legislative Assembly Office, out of funds appropriated for the remuneration of the Premier, and that Office may determine the form of the payments and the schedule according to which they are made.
